- 11. Validity of the offer should be 45 days from the date of opening of quotation
- 12. The LED Light fitting has i/c (inbuilt driver) shall have two years warranty from the date of supply of material at site. During the period, if any, defect found, the same will be replaced /repaired by you free of cost.

#### 13. Arbitration:

Any Dispute, differences, whatsoever, arising between the parties out of or relating to the work effect of this contract shall be settled between the SCOPE and the contractor amicably.
