- Bidders have to download the Bid documents from the e-procurement portal i.e. www.tenderwizard.com/SCOPE after registering themselves on portal and submit e-bids after payment of bid processing fee & Bid documents fee before last date & time of downloading the e-bids online. Bidders can also view the NIT, SCOPE of work on www.scopeonline.in. For e-tendering support call 8799753401.
- Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.
- Tender document shall be accepted only from DJB registered reputed, specialized Contractors working with CPWD/PWD/MES/Railway/PSUs/ Autonomous Bodies/ SCOPE who fulfill following pre-qualification criteria & showing their original documents in this regard:

- 4.1 Proof of experience of having successfully completed Similar works during the last 7 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender in the last five years.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender in the last five years.

OR

One similar completed work of aggregate cost not less than the amount equal to 80% of the estimated cost put to tender in the last five years.

Similar works means Rain water harvesting works.

- 4.2 The Tenderer must be registered under ESI, PF, GST & income tax act and should have PAN number. The copies of registration papers along with details need to be furnished. Latest ESI & PF deposit with challan authority is also needed.
- 4.3 All the above certificate/documents shall be submitted by the firm duly signed & self attested subject to verification with original documents.
- 4.4 Hard copy of form of tender duly signed and stamped must be submitted along with tender cost and EMD.
- 4.5 The contractor must be registered with Delhi Jal Board (DJB).
5. **The tender shall be submitted through only E-Portal i.e. www.tenderwizard.com/SCOPE.**
6. Tenders are invited to submit their offers strictly based on the layout, design parameters, Specific requirements, terms & conditions and specifications and instruction to bidder given in the tender document.
7. Earnest money & tender cost mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favour of “MMO SCOPE Minar”. Tenders without Earnest Money submitted will be summarily rejected and the representative of such tenderers shall not be allowed to attend tender opening.
8. Pre -bid meeting shall be held at 15.09.2021 at 3:00 PM if required.
9. SCOPE reserves the right to reject any or all tenders without assigning any reasons.

SCOPE OF WORK

The Scope of work shall, inter alia, include the following:

1. To execute to the work as per items mentioned in the schedule of only as per latest CPWD DSR & other relevant specification and market rates.
2. The work is to be executed in an occupied building where PSU offices are functioning. Hence, work shall be done in a proper manner with minimum disturbance to the working environment of the building. The rate to be quoted for each item & for all leads, lifts at the above mentioned places in SCOPE Minar. Nothing extra shall be payable.
3. The contractor should carry out the work with utmost care to as to not disturb/dispute/damage the interiors done by various constituent PSUs of the building.
4. The disposal of removal material shall be done in a systematic manner away from the grounds of SCOPE Minar and it shall not be allowed to accumulate.
5. Dismantled portions become most vulnerable places till the PROVISION OF RAIN WATER HARVESTING SYSTEM AT SCOPE MINAR, LAXMI NAGAR, DELHI-92 work is carried out.
6. Supply & application of all the consumables complete in all respect.
7. Proper site clearance after completion of work and during the progress of work as per instructions of Engineer-in-Charge.
8. Dismantled surplus material should be dispose off from the site to stores of SCOPE as per directions of Engineer-In-Charge.
9. After completion of work and during progress of work, proper site clearance should be done as per the directions of Engineer-In-Charge.
10. Supply & fixing of all the materials required to carry out the work including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.
11. As this work is to be carried out in locations where offices of the constituents of SCOPE Minar are functioning, contractor has to work in such manner that constituents face minimum disturbance. For this purpose contractor may have to work in late hours or after office hours or on holidays including Sundays etc.
12. The work shall be carried out in such a way that no damage to the property of SCOPE/Building occurred and in case of any damage to the same contractor is liable to replace/provide the same.
13. To obtain clearness from DJB after completion of work to claim 10% rebate on water bill.
