

3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.

4. Tender shall be accepted only from the Authorized dealers / Authorized Contractor/ Authorized Suppliers of Vikram Solar on production of authorization letter / certificate, working experience with CPWD/ PWD/ MES/ Railway/ PSUs/ Autonomous Bodies/ SCOPE who fulfil following pre-qualification criteria & showing the original document in this regard:
- 4.1 Proof of having successfully completed similar works during the last 05 years ending last day of the month previous to the one in which applications are invited:
- Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.
- OR
- Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.
- OR
- One similar completed works of aggregate cost not less than the amount equal to 80% of the estimated cost.
- 4.2 The tenderer must be registered under GST & Income Tax act and PAN No. copies of registration papers along with details need to be furnished, subject to verification with the original documents if required.
- 4.3 Similar completed works shall mean works SITC of Design and Supply, Installation, Testing and Commissioning of SPV Power plant.
- 4.4 **The Bidder must either be an Authorized dealers / Authorized Contractor/ Authorized Suppliers for the supply, installation and Testing and Commissioning of Solar System.**
- 4.5 Should furnish undertaking stating that firm is not blacklisted anywhere.
