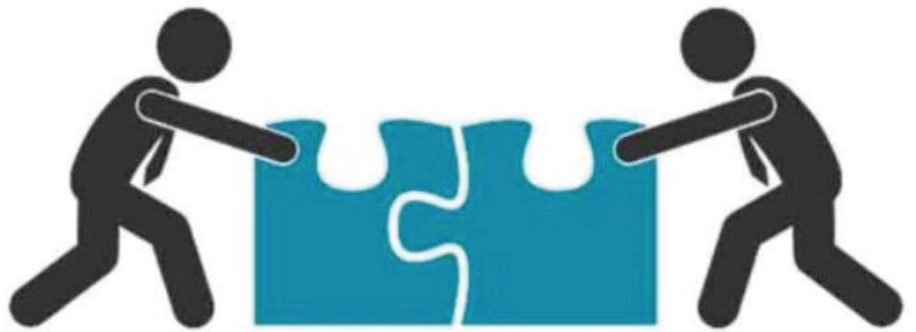
RESOURCE PERSONS
