3. Tender document shall be issued only to reputed, specialized Contractors / Manufactures working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing the original document in this regard.

4. The bidder must have five years of experience of temporary illumination work in government department/PSUs/Autonomous Bodies. The bidder should provide work order and completion certificate
Similar works means, "Temporary illumination on high rise buildings".
Three similar completed similar works, each costing not less than the amount equal to 40% of estimated cost put to tender.
OR
Two similar completed similar works, each costing not less than the amount equal to 60% of the estimated cost put to tender.
- 5 Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
- 6 Copies of similar works executed / in hand for high rise multi- storeyed office building during last three years along with work order & clients performance certificate.
- 7 Tenderers are advised to submit their offers strictly based on the layout, design parameters, specific requirements, terms & conditions and specifications given in the tender documents.
- 8 The bidder must be registered under GST and should have PAN no and should have valid Electrical Contractor License. Copies of registration papers along with details need to be furnished.
