2. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
3. Tender document shall be issued only to OEM M/s Wipro India Ltd or their Authorized Dealer/Channel Partner on production of authorized certificate, working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing the original document in this regard.



- 3.1 Experience of having successfully completed similar works i.e” **SITC of façade lighting on office buildings** “ during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed similar works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed similar works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed similar work of aggregate cost not less than the amount equal to 80% of the estimated cost.

Similar works means, “SITC of façade lighting on office buildings”.

4. Tenderer must be registered under ESI, PF, GST, Income Tax act, PAN No. and ESI and PF latest challan. Copies of registration papers along with details need to be furnished.
5. Average annual financial turn over on Electrical works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year. Balance sheet for the last three years to submitted in this regard.
6. Similar work shall mean a project consisting of “Supply, installation, Testing & commissioning of Facade lighting system individually or in any combination of works in a single project in which the façade lighting part is of the required amount as alone.
7. Tenderer shall propose design of façade lighting along with complete details of light fixtures and Bill of Quantity of proposed design including cables and other accessories which has been considered in the design. The cost of all the above shall be quoted in price bid.
8. **Copies of similar works executed / in hand for office building during last five years along with work order & clients performance certificate.**
9. All the above certificate / documents shall be submitted by the firm duly signed & self attested subject to verification with original documents.
10. The tender shall be submitted through only portal i.e www.tenderwizard.com/SCOPE.
11. **Hard copy of form of tender duly signed & stamped shall be submitted along with tender cost and EMD.**
12. The tender shall be submitted: thorough portal i.e www.tenderwizard.com/SCOPE.



13. Tenders are invited to submit their offers strictly based on the layout, design parameter, specific requirement, terms & conditions and Specifications given in the tender document and instruction to bidder.
