SCOPE OF WORK

- 1. Surface Preparation:- Removing biitumen and cementitious coating from stone surface. Cleaning and grinding the surface from dust mortar splashes and loosely adhering particles. Repairing of all cracks/joints and honey combing with rich cement sand mortar admixed with integral waterproofing compound Cico Letax SBR/Cico super. Providing and laying 1: 4 (cement: sand) coving of size 50 x 50 mm in all horizontal and vertical edges in round shape admixing water proofing compond on wet coat of CICO SBR LATEX
- Surface Cleaning- Cleaning of Stone surface to remove dust, loose particles, etc. with compressed air or any other suitable technique depending on site conditions, grinding any sharpedges, etc.
- Waterproofing Coat: Providing and applying two coat single component pure polyurethane based liquid cold applied elastomeric waterproofing membrane CICO Chem 500 I having elongation at break >550-600% in two coats at the average consumption rate of 1.20 -1.50 kg per sqm before prime with Cico Corchem 2P.
- Disposal of mulba / debris from outer parking of SCOPE Minar by mechanical means and disposing the same to the nearest disposal area including loading, unloading and transportation etc. complete.
- After completion of work and during progress of work, proper site clearance should be done as per the directions of Engineer-In-Charge.
- Supply & fixing of all the materials required to carryout the work including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.
- 7. Contractor shall got approved the sample of materials before supply at site.
- 8. As this work is to be carried out in locations where offices of the constituents of SCOPE Minar are functioning, contractor has to work in such manner that constituents face minimum disturbance. For this purpose contractor may have to work in late hours or after office hours or on holidays including Sundays etc.
