**NOTICE INVITING TENDER**

**Sub: Replacement of Existing Dry Type Transformer with new 2000 KVA,  
11 KV/433 Volts Transformer with OLTC in Sub-station No.II (Phase-I)  
at SCOPE Complex, 7-Lodhi Road, New Delhi-110003.**

1. Online e- tenders are invited by General Manager (Tech. & HR) SCOPE on behalf of Constituents of SCOPE Complex, Lodi Road, New Delhi – 110 003 for the subject work as per the details given below:-
  - 1.1 Name of the work : Replacement of Existing Dry Type Transformer with new 2000 KVA, 11 KV/433 Volts Transformer with OLTC in Sub-station No.II (Phase-I) at SCOPE Complex, 7-Lodhi Road, New Delhi-110003.
  - 1.2 Estimated Cost : Rs.1,31,06,790.00 plus GST @18%
  - 1.3 Earnest Money : Rs.3,09,320.00
  - 1.4 Time for completion : Four months from the date of issuance of LOI.
  - 1.5 Tender Processing Fee : Rs.7670.00
  - 1.6 Cost of tender : Rs 1120.00
  - 1.7 Commencement of download E –Bid : 07.07.2023 from 10.00 A.M.

  - 2.3 Bidders have to download the Bid documents from the e-procurement portal i.e. **www.tenderwizard.com/SCOPE** after registering themselves on portal and submit e-bids after payment of Bid Processing Fee & Bid documents fee before last date & time of downloading the e-bids online (**For E-Tendering support:- 8799753401, 080-45811365**). Bidder can also view the NIT, SCOPE of work on **www.scopeonline.in**.
  - 2.4 Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.



4. Tender document shall be accepted only from reputed, specialized contractors in the similar field working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE, who fulfill following pre-qualification criteria producing their original documents in this regard:
- 4.1 Experience of having successfully completed atleast one job of Dry type Transformer with a capacity not less than 2 MVA of 11KV or 33KV level of aggregate cost not less than the amount equal to 80% of the estimated cost put to tender during the last 5 years ending last day of the month previous to the one in which applications are invited:
- OR
- Two job of Dry type Transformer with a capacity not less than 1.5 MVA of 11KV or 33KV level, each costing not less than the amount equal to 60% of the estimated cost put to tender during the last 5 years ending last day of the month previous to the one in which applications are invited:
- OR
- Three job of Dry type Transformer with a capacity not less than 1 MVA of 11KV or 33KV level, each costing not less than the amount equal to 40% of the estimated cost put to tender during the last 5 years ending last day of the month previous to the one in which applications are invited:
5. The Transformer must be got manufactured From any one of the approved make as given in the tender. Undertaking for the same shall be uploaded by the firm duly signed & self attested subject "That we undertake that the transformers will be got manufactured from any one manufacturer as mentioned as per makes of material given in the tender up to the satisfaction of EIC and after completion of work, certificate (in original) from the manufacturer shall also be submitted to SCOPE regarding satisfactory commissioning of Transformer.
6. Tenderer must be registered under ESI, PF, GST, Income Tax act, PAN No. and should have valid Class I Electrical Contractor License. Copies of registration papers alongwith details need to be furnished Latest ESI & PF deposit with challan authority is also needed.
7. Average annual financial turnover on Electrical construction works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year along with Balance sheet for previous three years with ITR to be submitted.
8. All the above certificate/documents shall be submitted by the firm duly signed & self attested subject to verification with original documents.
9. Hard copy of Forms of Tender duly signed & stamped must be submitted during submitting of EMD & tender fee.





10. The tender shall be submitted through only E-Portal i.e. [www.tenderwizard.com/SCOPE](http://www.tenderwizard.com/SCOPE).
11. Tenderers are invited to submit their offers strictly based on layout, design parameters, Specific requirements, terms & conditions and specifications & instructions to bidder given in the tender documents.
12. Cost of tender documents & Earnest Money mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favour of "SCOPE Complex MMO Account". Tenders without Earnest Money Deposit submitted will be summarily rejected and the representative of such tenderers shall not be allowed to attend tender opening.
13. Pre-bid conference shall be held at 3.00 P.M. on 18.07.2023, if required.
