3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.



4. Tender shall be accepted only from the reputed specialized Contractors / Manufactures working with CPWD/ PWD/ MES/ Railway/ PSUs/ Autonomous Bodies/ SCOPE who fulfil following pre-qualification criteria & showing the original document in this regard:

4.1 Proof of having successfully completed similar works during the last 05 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed works of aggregate cost not less than the amount equal to 80% of the estimated cost.

4.2 The tenderer must be registered under ESI, PF, GST & Income Tax act and PAN No. copies of registration papers along with details need to be furnished. Latest ESI & PF deposit with challan authority is also needed, subject to verification with the original documents if required.

4.3 Average annual financial turn over should be at least 1.5 times of the estimated cost during the immediate last 3 consecutive financial year.

4.4 Balance sheet for previous three years with ITR.

4.5 Should furnish undertaking stating that firm is not blacklisted anywhere.
