4. **Bid shall be accepted only from Manufacturer M/s Wipro India lighting or M/s Philips India Lighting and their Authorized Dealer /channel partner**, on production authorization Letter /certificate from manufacturer. Documentary proof shall be uploaded by the firm duly signed and self-attested subject to verification with the original documents.
5. Tenderers are advised to submit their offers strictly based on the make, model, design parameters, specific requirements, terms & conditions and technical specifications given in the tender documents.



6. The bidder must be registered under GST and should have PAN no. Copies of registration papers along with details need to be furnished.
