SCOPE OF WORK

The SCOPE Minar is a stat of art office building located at Laxmi Nagar District Centre, Delhi-92 comprising of twin tower namely North Tower & South Tower. North Tower is G+ Mezz. +20 floor (Core-1 &2) and South Tower is G+Mezz. +15 floor (Core-3 &4) where in space is reserved for offices of various Govt. of India Enterprises. There are four numbers of Tractel Trifor (I) pvt. Ltd. and Apple tree make Façade Cleaning Roof Trolleys two each located in the terrace level of the North & South Tower. It is intended to supply & Installation of Guide rail and modification of Roof top Trolleys of North Tower.

The Scope of work shall, inter alia, include the following:

- Supply of the following materials for Guide track to be installed on parapet wall for 2 nos. Roof Top Trolleys of North Tower at SCOPE Minar:
- a. 75X75X6.0 mm hot dipped galvanized square pipe guide track fabricated in curved shape suitable for parapet wall mounted bracket.
- b. MS hot dipped galvanized parapet mounted bracket suitable for laying of guide track of 75X75X6mm sizes.
- c. M16X165 mm anchor bolt of SS 304 with grouting chemical (Hilti/Fisher)
- d. Overhauling & Servicing / Repairing of all trolleys including gear box , drive motor, wire rope, bearings, electrical panels etc.
- 2 Installation of all the above materials including labour, all consumables, machinery, tools, tackles etc complete in all respect as per site requirement.
- 3. Necessary modification in existing track guide assembly of Roof Top Trolleys/BMU to suite for parapet mounted guide track including all required materials, consumables, labour, tools & tackles etc complete in all respect.
