2. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
3. Tender document shall be issued only to reputed, OEM/Authorized Channel partner/ A Class Electrical Contractor / Manufactures working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing the original document in this regard.

- 3.1 Experience of having successfully completed similar works i.e. "Supply, Installation, Testing and commissioning of Electrical Distribution panel " during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed similar works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed similar works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed similar work of aggregate cost not less than the amount equal to 80% of the estimated cost.

**Similar works means, Supply, Installation" Testing and commissioning of Electrical Distribution panel"**

4. Tenderer must be registered under ESI, PF, GST, Income Tax act, PAN No. and should have valid Electrical Contractor License. Copies of registration papers along with details need to be furnished Latest ESI & PF deposit with challan authority is also needed.
5. The bidder must qualify all of the following requirements to participate in the bidding process.
  - a. The bidder should have manufacturing capacity of minimum 10-15 nos. panel per month.
  - b. The bidder shall have servicing, repairing, testing & refurbishment facility in INDIA with necessary spares and manufacturing's equipment like CNC machine for cutting and bending. Details of the set-up must be provided, failing which the offer will be rejected. The bidder shall submit undertaking along with the technical bid confirming compliance to qualifying criteria for bidder.
  - c. The bidder should have supplied at least 15 nos. panels/switchboards to any industries i.e already mention in clause no.3.1, in last 3 years out of which at least 50% should be in successful operation
  - d. The Bidder must possess valid ISO 9001:2015 , 14001:2015, 45001:2018 certificate.
  - e. An undertaking (self-certificate) that the bidder has not been blacklisted/debarred by any central/state government institution including electricity utility.
6. Average annual financial turn over on Electrical works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year and copy of Balance sheet with ITR for previous three years.
7. The financial data shall be certified by Chartered Accountant with his stamp and signature.
8. All the above certificate / documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents.
9. The tender shall be submitted through only portal i.e <https://scope.ewizard.in>.
10. Hard copy of form of tender duly signed & stamped shall be submitted along with tender cost and EMD.
