3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.

4. Tender document shall be accepted only from reputed specialized contractors who are working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing their original documents in this regard:



- 4.1 Proof of having successfully completed works during last five years ending last day of month previous to the one in which application are invited.

Three similar completed comprehensive AMC of Window/Split/Cassette/ductable ACs value not less than 40% of the estimated cost put to tender.

OR

Two similar completed comprehensive AMC of Window/Split/Cassette/ductable ACs value not less than 60% of the estimated cost put to tender.

OR

One similar completed comprehensive AMC of Window/Split/Cassette/ductable ACs value not less than 80% of the estimated cost put to tender.

- 5.0 The Tenderer must be registered under ESI, PF, GST & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.
- 6.0 Average annual financial turn over on AC works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year.
- 7.0 Balance sheet for previous three years with ITR.
- 8.0 Copies of similar works executed / in hand for multi-storeyed office building & industry during last three years along with work order & clients performance certificate.
- 9.0 All the above certificate / documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents
- 10.0 Hard copy of Form of Tender duly signed & stamped must be submitted during submitting of EMD & Tender cost in the tender box placed at UL floor, Core-II, SCOPE Minar, Laxmi Nagar, Delhi-110092.
- 11.0 The tender shall be submitted through only portal <http://ewizard.com/SCOPE>
- 12.0 Tenders are invited to submit their offers strictly based on the layout, design parameters, specific requirements, terms & conditions and specifications given in the tender document and instruction to bidder.
