Bidders have to download the bid documents from the e-procurement portal i.e https://scope.ewizard.in after registering themselves on portal and submit e-bids after payment of Bid processing Fee & Bid documents fee before last date & time of downloading E-Bid online (For tendering support: -9355030607. 9355030630. Bidder can also view the E-NIT, SCOPE of work on www.scopeonline.in.
- 2. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
- 4. Tender document shall be accepted only from Manufacturer / Channel Partners or their authorized contractors of Orient-Firex/ Hilti/Fischer/Promat/3M/STI working with CPWD / PWD / MES / Railway / PSUs / Autonomous Bodies / SCOPE who fulfill following pre-qualification criteria producing their original documents in this regard:
- 4.1 Experience of having successfully completed similar works during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed works of aggregate cost not less than the amount equal to 80% of the estimated cost.

"Similar works shall mean "S/I/T/C of Fire smoke barrier system in multi-storeyed office building & industry".

The past experience should be supported by certificates issued by Client's organization.

- 5. The Tenderer must be registered with GST & Income Tax act and should have PAN number, PF, ESI registration. The copies of registration papers along with details need to be furnished. Latest ESI & PF deposit with challan is also needed.
- 6. Copies of similar works executed during last 5 years along with client's performance certificate.
- 7. The agency has to upload & submit valid certificate of Manufacturer / channel partner or their authorized contractor of **Orient-Firex/ Hilti/Fischer/Promat/3M/STI** Make.
- 8. Average annual financial turn over should be at least 100% of the estimated cost during the immediate last 03 consecutive financial year. Balance sheet for previous last three years along with I.T.R to be submitted.

- 9. All the above certificate/documents shall be submitted by the firm duly signed & self attested subject to verification with original documents.
- 10. Hard copy of Forms of Tender duly signed & stamped must be submitted during submitting of EMD & tender fee in the tender box placed at UL floor, Core-2 at SCOPE Minar, Laxmi Nagar, Delhi-110092.
- 11. The tender shall be submitted through only portal i.e., https://scope.ewizard.in.
- 12. Tenderers are invited to submit their offers strictly based on layout, design parameters, Specific requirements, terms & conditions and specifications & instructions to bidder given in the tender documents.
- 13. Cost of tender documents & Earnest Money mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favour of "MMO SCOPE Minar". Tenders without Earnest Money Deposit submitted will be summarily rejected and the representative of such tenderers shall not be allowed to attend tender opening.
- 14. Pre-bid Conference shall be held at 05.03.2024 PM at 3:00 PM, if required.
- 15. SCOPE reserves the right to reject any or all tenders without assigning any reasons.

SCOPE OF WORK

The Scope of work shall, inter alia, include the following:

- 1. To execute to the work as per items mentioned in the schedule of only as per latest CPWD DSR & other relevant specification and market rates.
- 2. The work is to be executed in an occupied building where PSU offices are functioning. Hence, work shall be done in a proper manner with minimum disturbance to the working environment of the building. The rate to be quoted for each item & for all leads, lifts at the above mentioned places in SCOPE Minar. Nothing extra shall be payable.
- The contractor should carry out the work with utmost care to as to not disturb/dispute/damage the interiors done by various constituent PSUs of the building.
- 4. The disposal of removal material shall be done in a systematic manner away from the grounds of SCOPE Minar and it shall not be allowed to accumulate.
- Dismantled portions become most vulnerable places till the "S/I/T/C of 2
 hrs. Fire rated material to fill the gap between glass façade and wall
 at SCOPE Minar, Laxmi Nagar, Delhi-110092." work is carried out.
- 6. Supply & application of all the consumables complete in all respect.
- 7. The test certificate for Smoke barrier system from the manufacture should be submitted, after completion of work.
- 8. Proper site clearance after completion of work and during the progress of work as per instructions of Engineer-in-Charge.
- Dismantled surplus material should be disposed of from the site to stores of SCOPE as per directions of Engineer-In-Charge.
- After completion of work and during progress of work, proper site clearance should be done as per the directions of Engineer-In-Charge.
- 11. Supply & fixing of all the materials required to carry out the work including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.

- 12. As this work is to be carried out in locations where offices of the constituents of SCOPE Minar are functioning, contractor has to work in such manner that constituents face minimum disturbance. For this purpose, contractor may have to work in late hours or after office hours or on holidays including Sundays etc.
- 13. The work shall be carried out in such a way that no damage to the property of SCOPE/Building occurred and in case of any damage to the same contractor is liable to replace/provide the same.
