SCOPE OF WORK

The Scope of work shall, inter alia, include the following:

- The scope of work shall includes cleaning and preparation of surface by filling of pot holes, joints, cracks etc. upto the satisfaction of Engineer In-Charge.
- Supply & application of all materials etc required to carryout above said works, job including all consumables in the scope of work of contractor. Nothing shall be paid extra on this account.
- Contractor shall got approved the sample of materials before supply at site.
- Proper cleaning & site clearance during the progress of work and after completion of work as per instructions of Engineer In-Charge.
- Special tools and tackles as required shall be arranged by the contractor.
- Providing temporary lighting as required.
- Providing safety appliances to workmen inline with statutory requirements.
- Removal and disposal of mulba of generated during execution of the work and handing back the site in clean condition.
