L&T and their authorized Service Centre on production of valid authorization certificate, working with CPWD/PWD/MES/Railways/PSU's/Autonomous bodies/SCOPE, who fulfill following pre-qualification criteria & showing their original documents in this regard:

Having experience of successfully completed works during the last 5 years ending previous day of last date of submission of tenders.
