- 2.4 Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.
- 3. Tender document shall be accepted only from reputed specialized contractors / manufacturers working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing their original documents in this regard:
- 3.1 Proof of having successfully completed works during last five years ending last day of month previous to the one in which application are invited.

Three similar completed S.I.T.C work of airhandling units containing capacity of 15000cfm and above. The value not less than 40% of the estimated cost put to tender.

OR

Two similar completed S.I.T.C work of airhandling units containing capacity of 15000cfm and above. The value of contract not less than 60% of the estimated cost put to tender.

OR

One similar completed S.I.T.C work of airhandling units containing capacity of 15000cfm and above. The value of contract not less than 80% of the estimated cost put to tender.

- 3.2 The Tenderer must be registered under ESI, PF, GST & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.
- 3.3 Average annual financial turn over on HVAC works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year.
- 3.4 Balance sheet for previous three years with ITR.
- 3.5 All the above certificate / documents shall be submitted by the firm duly signed & self attested subject to verification with original documents
- 3.6 Hard copy of "Form of tender" duly signed & stamped must submitted during submission of tender through e-portal along with tender cost & EMD.
- 3.7 The agencies are strictly advised to visit the Airhandling units 25000cfm each before quoting their rates in the tender. An undertaking of visit shall be submitted to scope duly signed in between contractor & concern engineer of SCOPE. The undertaking must be uploaded on the site of e-wizard alongwith the bids, failing which tender will not be considered/rejected for opening of price bid.
