1. Online e-tenders are invited by General Manager-Tech & HR, SCOPE on behalf of Constituents of SCOPE Complex, 7 Lodhi Road, New Delhi-110003 for the following work:

  - 1.2 Estimated Cost : ₹ 13,47,856/- plus GST @ 18%.

2. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
3. Tender document shall be accepted only from the OEM i.e. **PANASONIC, AVIGILON, ARECONT VISION** or their authorized system integrators / channel partners on production of authorization Letter/certificate. (The past experience in similar nature of work should be supported by certificate issued by PWD/PWD/MES/Railways/PSUs/Autonomous Bodies/SCOPE) & showing the original document in this regard:
  - 4.1 Proof of having successfully completed similar works during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed works of aggregate cost not less than the amount equal to 80% of the estimated cost.

**“Similar works shall here mean “S.I.T.C. of CCTV system.”**

- 4.2 The tenderer must be registered under ESI, PF, GST & Income Tax act and PAN No. copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.
  - 4.3 Average annual financial turn over should not be less than 100% of the estimated cost during the immediate last 3 consecutive financial years.
  - 4.4 Balance sheet for previous three years with ITR.
  - 4.5 Copies of similar works executed / in hand for multi-storied office building & industry during last five years along with work order & clients performance certificate.
4. The tender shall be submitted through only portal i.e. <https://scope.ewizard.in>
  5. All the above certificate/documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents.
  6. **Hard Copy of “Form of Tender” duly signed & stamped must be submitted during submission of tender through e-portal along with tender cost & EMD.**
  7. Tenderers are invited to submit their offers strictly based on the terms & conditions and specifications given in the tender document and instruction to bidder.
  8. Cost of Tender & Earnest money mentioned above should be paid by crossed Demand Draft/Pay orders from any nationalized /Schedule Bank in favour of **“SCOPE COMPLEX MMO ACCOUNT”**. Tenders without Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.
