

NOTICE INVITING TENDER

1. Online e-tenders are invited by General Manager (Tech. & HR), SCOPE on behalf of Constituents of SCOPE Complex, Lodhi Road, New Delhi – 110 003 for the subject work as per the details given below :-
- 1.1 Name of the work : **Provision of earthing system and loop earthing for Sub-stations at SCOPE Complex, 7-Lodhi Road, New Delhi -110003.**
- 1.2 Estimated Cost : **Rs.6,59,126.00 plus GST @18%**
- 1.3 Earnest Money : **Rs.15,560.00**
- 1.4 Time for completion : **One month from the date of issuance of LOA**
- 1.5 Tender Processing Fee : **Rs.584.00**
- 1.6 Cost of tender : **Rs.560.00**

- 2.3 Bidders have to download the Bid documents from the e-procurement portal i.e. **<https://scope.ewizard.in>** after registering themselves on portal and submit e-bids after payment of Bid Processing Fee & Bid documents fee before last date & time of downloading the e-bids online (**For E-Tendering support:-9355030607, 9355030630**). Bidder can also view the NIT on www.scopeonline.in.



2.4 Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.

4. Tender document shall be accepted only from manufacturer/specialized contractors, working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE and fulfill following pre-qualification criteria & showing their original documents in this regard:

Having experience of successfully completed works during the last 5 years ending previous day of last date of submission of tenders.

Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works costing not less than the amount equal to 60% of estimated cost put to tender.

OR

One similar completed works costing not less than the amount equal to 80% of estimated cost put to tender.

- 4.1 The Tenderer must be registered under GST & income tax act and should have PAN No. Copies of registration papers also required.
- 4.2 The Tenderer must be registered under ESI, PF, GST & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.
- 4.3 Average annual financial turn over on Electrical work should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year.
- 4.4 ITR with Balance sheet for previous three years.
- 4.5 The Tenderer should have a valid Electrical Contractor's Licence.
- 4.6 **Hard copy of Forms of Tender duly signed & stamped must be submitted alongwith EMD & Tender cost.**
- 4.7 All the above certificate / documents shall be uploaded by the firm duly signed & self attested subject to verification with original documents
- 4.8 The agencies are strictly advised to visit the site before quoting their rates in the tender. An undertaking of visit shall be submitted to SCOPE duly signed in between contractor & concern Engineer of SCOPE. The undertaking must be uploaded on the site of e-wizard alongwith the bids, failing which tender will not be considered/rejected for opening of price bid.

Tenders without cost of tender and Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.
