Tender document shall be accepted only from OEM/ or an Authorized channel Partner of OEM i.e. MAGNETIC / BENINCA (active component) & for passive component MOTOROLA / HID / IDCUBE / NEC/ LENEL / MERCURY / DORLET and their authorized system integrators/ channel partners on production of authorization Letter/certificate. - 5.5 Copies of similar works executed / in hand for multi-storied office building & industry during last three years along with work order & clients performance certificate.
