#### **INSTRUCTION TO THE BIDDERS**

- 1. Bidders have to download the Bid documents from the e-procurement portal i.e. <a href="https://scope.ewizard.in/">https://scope.ewizard.in/</a> after registering themselves on portal and submit e-bids after payment of tender processing fee & tender document fee before last date & time of downloading the e-bids online. Bidder can also view the NIT, on www.scopeonline.in. For E-tendering support:-9355030630, 9355030616.
- 2. Bidders are required to quote the license fee for Providing Food & Beverage Catering Services in SCOPE Convention Centre on monthly License Fee basis at SCOPE Complex and rates including all taxes except GST, strictly in the prescribed Proforma of Financial bid. Financial bid shall contain license fee charges only and no other documents shall be enclosed with the financial bid. Tender shall be awarded to the bidder based on QCBS criteria (Quality & Cost Based Selection Criteria).
- 3. Financial Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
- Documentary proof of providing the catering facility satisfactorily at Govt /PSUs/Autonomous bodies /SCOPE/ Reputed Organizations/ Reputed Hotels/Restaurants/Clubs for the past five years ending 31.03.2024. Relevant contract copies to be enclosed.
- 5. The bidder should have a minimum average annual financial turnover of INR 3 Cr from Food & Beverage Catering services for at least three of the last five Financial years (FY 2019-20, 2020-21, 2021-22, 2022-23, 2023-24). Copy of Income tax return and Audited Annual Accounts of the relevant years may be provided. - 6. The Bidder must be registered as per law including registration with GST & Income Tax act and should have valid PAN number, PF, ESI registration. Copies of registration certificates along with details need to be furnished with latest challan.

- 12. Bidder should not have been Black listed/Debarred by any Institute / establishment or Agency /PSUs / Autonomous Bodies/SCOPE. Self-certified letter to be submitted.
- 13. Bidders are advised to well acquaint themselves fully with the location of the building space and terms & conditions including all the provisions of the Tender Document before submission of their tender.
- 14. The bidder may visit the site and all its facilities and infrastructure and take full responsibility for directly obtaining all necessary information for preparing the bid. The cost of any such visit shall be borne entirely by the bidder and no claim in this regard shall be entertained by SCOPE.
