- 2.4 Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.
- 3. Tender document shall be issued only to reputed specialized contractors working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE and fulfill following pre-qualification criteria & showing their original documents in this regard:
- 3.1 Proof of having successfully completed works during last five years ending last day of months previous to the one in which application are invited.

OR

Three similar completed HVAC Work containing Condenser/Chiller Pump installation's value not less than 40% of the estimated cost.

OR

Two similar completed HVAC Work containing Condenser/Chiller Pump installation's value not less than 60% of the estimated cost.

OR

One similar completed HVAC Work containing Condenser/Chiller Pump installation's value not less than 80% of the estimated cost.

- 3.2 The Tenderer must be registered under ESI, PF, GST & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.
