- 3. Tender document shall be issued only to reputed specialized contractors working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE as an approved Contractor of Indraprastha Gas Ltd.(IGL) and fulfill following pre-qualification criteria & showing their original documents in this regard:
- 3.1 Proof of having successfully completed works during last five years ending last day of months previous to the one in which application are invited.

OR

Three similar completed PNG Gas Pipe Line work through IGL each of the value not less than 40% of the estimated cost.

OR

Two similar completed PNG Gas Pipe Line work through IGL each of the value not less than 60% of the estimated cost.

OR

One similar completed PNG Gas Pipe Line work of the value not less than 80% of the estimated cost.
