- 2.3 Bidders have to download the Bid documents from the e-procurement portal i.e. <https://scope.ewizard.in> after registering themselves on portal and submit e-bids after payment of Bid Processing Fee & Bid documents fee before last date & time of downloading the e-bids online (For E-Tendering support: 9355030607, 9355030630). Bidder can also view the NIT, scope of work on [www.scopeonline.in](http://www.scopeonline.in).
- 2.4 Bids shall be submitted through e –bidding mode only. No other mode of Bid submission shall be accepted.

3. Tender document shall be issued only to reputed specialized contractors working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE as an approved Contractor of Indraprastha Gas Ltd.(IGL) and fulfill following pre-qualification criteria & showing their original documents in this regard:
  - 3.1 Proof of having successfully completed works during last five years ending last day of months previous to the one in which application are invited.

OR

Three similar completed PNG Gas Pipe Line work through IGL each of the value not less than 40% of the estimated cost.

OR

Two similar completed PNG Gas Pipe Line work through IGL each of the value not less than 60% of the estimated cost.

OR

One similar completed PNG Gas Pipe Line work of the value not less than 80% of the estimated cost.
  - 3.2 The Tenderer must be registered under ESI, PF, GST & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.
  - 3.3 Average annual financial turn over on IGL works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year.
  - 3.4 Balance sheet for previous three years.
  - 3.5 All the above certificate / documents shall be submitted by the firm duly signed & self attested subject to verification with original documents
  - 3.6 The agencies are strictly advised to visit the site before quoting their rates in the tender. An undertaking of visit shall be submitted to scope duly signed in between contractor & concern engineer of SCOPE. The undertaking must be uploaded on the site of e-wizard alongwith the bids, failing which tender will not be considered/rejected for opening of price bid.
4. The tender shall be submitted through only portal i.e., <https://scope.ewizard.in>.
5. **Hard copy of "Form of Tender" duly signed & stamped shall be submitted alongwith tender cost and EMD**
6. Tenders are invited to submit their offers strictly based on the terms & conditions and specifications given in the tender document and instruction to bidder.
