- 3. Tender document shall be issued only to reputed specialized contractors working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE/Private Sector and fulfill following pre-qualification criteria & showing their original documents in this regard:
- 3.1 Proof of having successfully completed works during last five years ending last day of months previous to the one in which application are invited.

OR

Three similar completed PNG Gas Pipe Line work each of the value not less than 40% of the estimated cost.

OR

Two similar completed PNG Gas Pipe Line work each of the value not less than 60% of the estimated cost.

OR

One similar completed PNG Gas Pipe Line work of the value not less than 80% of the estimated cost.

One completed job of any nature costing not less than the amount equal to 40% of the estimated cost put to tender with some Central/State Government Department/Autonomous Bodies/PSUs. In case of prominent specialised private firm.
