Bidders have to download the Bid documents from the e-procurement portal i.e. <https://scope.ewizard.in> after registering themselves on portal and submit e-bids after payment of bid processing fee & Bid documents fee before last date & time of downloading the e-bids online. Bidders can also view the NIT, SCOPE of work on www.scopeonline.in (For e tendering support-.9355030607and 9355030630.

2. **Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.**

3. Tender document shall be issued only to reputed, specialized Contractors / Manufactures working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing the original document in this regard.



- 4.1 Experience of having successfully completed similar works i.e” **Electrical Renovation/Rewiring work in high rise buildings** “ during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed similar works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed similar works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed similar work of aggregate cost not less than the amount equal to 80% of the estimated cost.

Similar works means, Electrical Renovation/Rewiring work in high rise buildings.

4. Tenderer must be registered under ESI, PF, GST, Income Tax act, PAN No. and should have valid Electrical Contractor License. Copies of registration papers along with details need to be furnished Latest ESI & PF deposit with challan authority is also needed.
5. Average annual financial turn over on Electrical works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year and copy of Balance sheet with ITR for previous three years.
6. All the above certificate / documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents.
7. The tender shall be submitted through only portal i.e <https://scope.ewizard.in>.
8. **Hard copy of form of tender duly signed & stamped shall be submitted along with tender cost and EMD.**
9. Tenders are invited to submit their offers strictly based on the layout, design parameter, specific requirement, terms & conditions and Specifications given in the tender document and instruction to bidder.
10. Cost of tender & Earnest Money mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favor of “**SCOPE Complex MMO Account**”. Tenders without Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.
