

## **NOTICE INVITING TENDER**

**Sub. : Supply, Installation, Testing & Commissioning of 20m<sup>3</sup>/hr Reverse Osmosis plant with connected accessories at SCOPE Complex, Lodi Road, New Delhi – 110003.**

1. Sealed item rate tenders are invited by General Manager (Tech) SCOPE on behalf of Constituents of SCOPE Complex, Lodi Road, New Delhi – 110 003. For the subject work as per the details given below:-
  - 1.1 Name of the work : **Supply, Installation, Testing & Commissioning of 20m<sup>3</sup>/hr Reverse Osmosis Plant with connected accessories at SCOPE Complex, 7-Lodhi Road, New Delhi-110003.**
  - 1.2 Estimated Cost : **Rs. 63,93,596.00 plus GST @18%**
  - 1.3 Earnest Money : **Rs. 1,50,890.00**
  - 1.4 Time for completion : **5 months from the date of issuance of LOI/ LOA.**
  - 1.5 Tender Processing Fee : **Rs. 5658.00**

- 2.3 Bidders have to download the Bid documents from the e-procurement portal i.e. **<https://scope.ewizard.in>** after registering themselves on portal and submit e-bids after payment of Bid Processing Fee & Bid documents fee before last date & time of downloading the e-bids online (**For E-Tendering support: 9355030607, 9355030630**). Bidder can also view the NIT, SCOPE of work on [www.scopeonline.in](http://www.scopeonline.in).
- 2.4 Bids shall be submitted through e –bidding mode only. No other mode of Bid submission shall be accepted.



3. Tender document shall be accepted only from manufacturer and their authorized dealers of ION Exchange/Thermax and other reputed working agencies who has installed the specified make of R.O. Plant and working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE and fulfill following pre-qualification criteria & showing their original documents in this regard:
- 3.1 Experience of having successfully completed works during last five years ending last day of months previous to the one in which application are invited.
- Three similar completed works containing minimum capacity 10m<sup>3</sup>/hr. and above each of the value not less than 40% of the estimated cost.
- OR
- Two similar completed works containing minimum capacity 10m<sup>3</sup>/hr. and above each of the value not less than 60% of the estimated cost.
- OR
- One similar completed works containing minimum capacity 10m<sup>3</sup>/hr. and above each of the value not less than 80% of the estimated cost.
- 3.2 The Tenderer must be registered under ESI, PF, VAT act, service tax act & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished. Copy of current challan of PF & ESIC.
- 3.3 Average annual financial turn over should be at least 1.0 times of the estimated cost during the immediate last 3 consecutive financial year.
- 3.4 Balance sheet for previous three years with ITR.
- 3.5 All the above certificate / documents shall be submitted by the firm duly signed & self attested subject to verification with original documents.
- 3.6 The hard copy of "Form of Tender" duly signed & stamped must submitted during submission of tender through e-portal alongwith the EMD & Tender cost.**
- 3.7 The complete tender documents shall be submitted through only e-portal i.e. <https://scope.ewizard.in>
- 3.8 The agencies are strictly advised to visit the site before quoting their rates in the tender. An undertaking of visit shall be submitted to scope duly signed in between contractor & concern engineer of SCOPE. The undertaking must be uploaded on the site of e-wizard alongwith the bids, failing which tender will not be considered/rejected for opening of price bid.
4. Tenders are invited to submit their offers strictly based on the layout, design parameters, specific requirements, terms & condition and specifications given in the tender document and instruction to bidder.



5. Earnest Money & Cost of Tender mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favour of **“SCOPE Complex MMO Account”**. Tenders without Earnest Money Deposit & Tender cost will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.
