3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
4. Eligibility Criteria: - Tender document shall be accepted only from reputed, specialized agencies working with CPWD, PWD, MES, Railway / PSUs/Autonomous Bodies/ SCOPE etc. Who fulfill the following eligibility criteria & showing the original documents in this regard:-
 - 4.1 Proof of having successfully completed similar works during the last 05 years ending last day of the month previous to the one in which applications are invited:
 - 4.2 Three service contracts for similar works, each not less than 40% total value of work OR
 - 4.3 Two service contracts for similar works, each not less than 60% total value of work OR
 - 4.4 One service contract similar works, each not less than 80% total value of work.

Similar works means, Operation & Maintenance of fire fighting systems of high rise buildings.

5. The Tenderer must be registered with GST & Income Tax act and should have PAN number, PF, ESI registration. Copies of registration papers along with details need to be furnished with latest challan.
6. The average annual financial turn over should not be less than 100% of the estimated cost during the immediate last 3 consecutive financial year. Balance Sheet for previous three years with ITR to be submitted in this regard.
7. The bidder shall furnish an undertaking affirming that the firm/agency has neither been blacklisted and debarred and nor their services have been banned or suspended due to any reason including corrupt and fraudulent practices in the past by any Govt. department/ Institutions/Local bodies/ Municipalities/ Public sector Undertaking/ Autonomous bodies etc. and there is no any vigilance/ CBI case pending against the firm/agency.
8. All the above certificate/documents shall be submitted by the firm duly signed & self attested subject to verification with original documents.
9. Hard copy of Forms of Tender duly signed & stamped must be submitted during submitting of EMD & tender fee.
10. The tender shall be submitted through only E-Portal i.e. <https://scope.ewizard.in>.



11. Tenderers are invited to submit their offers strictly based on Specific requirements, terms & conditions and specifications & instructions to bidder given in the tender documents.
