- 3. Tender document shall be accepted only from Specialized contractors who are working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE and fulfill following pre-qualification criteria & showing their original documents in this regard:
- 3.1 Proof of having successfully completed works during last five years ending last day of months previous to the one in which application are invited.
