Tender document shall be accepted only from reputed specialized contractors / manufacturers working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE OR Prominent specialized private firm working in private sectors who fulfill following pre-qualification criteria and showing their original documents in this regard:
- 3.1 Experience of having successfully completed works during the last 5 years ending previous day of last date of submission of tenders.

Three similar completed HVAC job containing the similar items of air purification work each of the value not less than 40% of the estimated cost put to tender.

OR

Two similar completed HVAC job containing the similar items of air purification work each of the value not less than 60% of the estimated cost put to tender.

OR
