

NOTICE INVITING TENDER

1. Online e- tenders are invited by General Manager (Tech. & HR), SCOPE on behalf of Constituents of SCOPE Complex, Lodhi Road, New Delhi - 110003 for the subject work as per the details given below:-
 - 1.1 Name of the work : Replacement of Existing Dry Type Transformer with new 2000 KVA, 11 KV/433 Volts Transformer with OLTC in Sub-station No.I (Phase-II) at SCOPE Complex,7-Lodhi Road, New Delhi-110003.
 - 1.2 Estimated Cost : Rs. 1,91,18,851.00 plus GST @18%
 - 1.3 Earnest Money : Rs.4,51,205.00
 - 1.4 Time for completion : Four months from the date of issuance of LOI/LOA.

 - 2.3 Bidders have to download the Bid documents from the e-procurement portal i.e. <https://scope.ewizard.in> after registering themselves on portal and submit e-bids after payment of Bid Processing Fee & Bid documents fee before last date & time of downloading the e-bids online(For E-Tendering support: 9355030607, 9355030630). Bidder can also view the NIT, scope of work on www.scopeonline.in

2.4 **Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.**

3. Tender document shall be accepted only from reputed specialized contractors / manufacturers working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing their original documents in this regard:

3.1 Proof of having successfully completed works during last five years ending last day of month previous to the one in which application are invited.

OR

Three similar completed works for SITC of Dry Type Transformers. The value of the works in scheduled item not less than 40% of the estimated cost put to tender.

OR

Two similar completed works for SITC of Dry Type Transformers. The value of the works in scheduled item not less than 60% of the estimated cost put to tender.

OR

One similar completed work for SITC of Dry Type Transformers. The value of the works in scheduled item not less than 80% of the estimated cost put to tender.

Similar works shall mean "SITC of Dry Type Transformers in multi-storeyed office building & industry"

The Transformer must be got manufactured from any one of the approved make as given in the tender. Undertaking for the same shall be uploaded by the firm duly signed & self attested subject. "That we undertake that the transformers will be got manufactured from any one manufacturer as mentioned as per makes of material given in the tender upto the satisfaction of Engineer-Incharge and after completion of work, certificate (in original) from the manufacturer shall be submitted to SCOPE".

3.2 The Tenderer must be registered under ESI, PF, GST & income tax act and should have valid Electrical Contractor Licence, PAN No. Copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.

3.3 Average annual financial turn over on Transformer & Sub-station works should be at least 1.5 times of the estimated cost during the immediate last 3 consecutive financial year. Balance sheet for previous three years with ITR to be submitted in this regard.

3.4 Copies of similar works executed / in hand for multi-storeyed office building & industry during last three years alongwith work order & clients performance certificate.

3.5 All the above certificate / documents shall be submitted by the firm duly signed & self attested subject to verification with original documents

- 3.6 The agencies are strictly advised to visit the site before quoting their rates in the tender. An undertaking of visit shall be submitted to scope duly signed in between contractor & concern engineer of scope. The undertaking must be uploaded on the site of e-wizard alongwith the bids, failing which tender will not be considered/rejected for opening of price bid.
4. The tender shall be submitted through only portal i.e. <https://scope.ewizard.in>.
5. **Hard copy of "Form of Tender" alongwith complete tender documents duly signed & stamped shall be submitted alongwith Tender cost and EMD**
6. Tenders are invited to submit their offers strictly based on the layout, design parameters, specific requirements, terms & conditions and specifications given in the tender document and instruction to bidder.
7. Earnest Money & Cost of Tender mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favor of **"SCOPE Complex MMO Account"**. Tenders without Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.
