SCOPE OF WORK

- Deployment of supervisor, electrician, technician, skilled and semi skilled / laboureres for carrying out the work as per specification/direction of supervising engineer/OIC.
- Making available checking, testing, measuring equipment/sets/instrument tools, meters, blowers etc. as required.
- Planning, scheduling and carrying out preventive maintenance of electrical installations and keeping record of it.
- 4) Repair/replacement of faulty/unusable items and keeping record of it.
- 5) Carrying out modifications suggested by supervising engineer / OIC.
- 6) Maintenance of daily log book of events, complaint register/file spares consumption register/files etc.
- 7) Advising for procurement of spares in time so that maintenance/operation is not held up for want of spares.
- 8) Arranging materials such as fuses, porcelain fuse base and carriers, locks for padlocking of switches, nuts, bolts, washers, screws, insulation tapes, PVC sleeves, welding electrodes etc. required for maintenance job is under the scope of work.
