Bidders have to download the Bid documents from the e-procurement portal i.e., <https://scope.ewizard.in> after registering themselves on portal and submit e-bids after payment of bid processing fee & Bid document fee before last date & at time of downloading the e-bids online. 3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.

4. The past experience in **Design, Printing and Supply of New Year 2026 SCOPE Executive Diaries** of work should be supported by certificate issued by PWD/PWD/MES/Railways/PSUs/Autonomous Bodies/SCOPE) & showing the original document in this regard:

Proof of having successfully completed similar works during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.

or

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

or

One similar completed works of aggregate cost not less than the amount equal to 80% of the estimated cost.

Similar works shall here mean “Design, Printing and supplying diaries”

5. **The bidder must visit the SCOPE office, Lodhi Road, New Delhi-110003 to have a look at the selected design of diary by SCOPE. The quote in the NIT shall be as per the selected diary by the SCOPE.**
6. The bidder must be registered under GST, Income Tax Act and should have PAN no. Copies of registration papers along with details need to be furnished.
7. The bidder should have a turnover not less than one crore annually during the last 3 years period. Documentary proof for the same is to be submitted.
8. Balance sheet for previous three years with ITR.
9. The bidder should have successfully delivered/supplied Diaries in any PSU/or other reputed organizations and should provide work order and completion certificate.
10. Forms of tender of Bid condition & specification must be submitted duly signed & stamped during submitting of Bid through e-portal on bidders' letter head.
11. All the above certificates /documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents.
12. Cost The tender cost (Form fee), Earnest Money (EMD) and Tender processing fee (TPF) must be paid by the bidder through online payment mode only, as provided on the e-tendering portal i.e., <https://scope.ewizard.in> . In case the bidder fails to technically qualify as per eligibility criteria of the tender or is not the Lowest (LI) bidder, the EMD amount will be refunded to the bidder's account details as provided on the bidder enrolment registration page of SCOPE e-tendering portal <https://scope.ewizard.in> .
13. The agencies are strictly advised to visit the SCOPE office before quoting their rates in the tender. An undertaking of visit shall be submitted to SCOPE duly signed in between contractor & concerned Officer-in-Charge. The undertaking must be uploaded on the site of e-wizard along with the bids, failing which tender will not be considered/rejected for opening of price bid.
