- 3 Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.
4. Tender document shall be accepted only from reputed specialized manufacturer / contractors who are working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing their original documents in this regard.

Experience of having successfully completed works during the last 5 years ending previous day of last date of submission of tenders.

4.1 Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender.

4.2 Two similar completed works costing not less than the amount equal to 60% of estimated cost put to tender.

“Similar works shall here mean Air conditioning work in multi-storeyed office building & industry”.
