2.0 Bidders have to download the bid documents from the e-procurement portal i.e. www.ewizard.com/SCOPE after registering themselves on portal and submit e-bids after payments of Tender processing Fee & Cost of Tender documents, before last date & time of downloading the e-bids online. Bidder can also view the NIT & Scope of work on www.scopeonline.in.

- 3 Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.

4. Tender document shall be accepted only from reputed specialized contractors working with CPWD/PWD/MES/Railways/ PSUs/ Autonomous bodies / private sector who fulfill following criteria & showing their original documents in this regard:

Experience of having successfully completed works during the last 5 years ending previous day of last date of submission of tenders.

4.1 Three similar completed work not less than the amount equal to 40% of estimated cost put to tender.

OR

4.2 Two similar completed work not less than the amount equal to 60% of estimated cost put to tender.

OR

4.3 One similar completed work not less than the amount equal to 80% of estimated cost put to tender.

Similar works shall here mean painting work of pipe line in multi-storeyed office building & industry

- 5.0 The Tenderer must be registered under PF, ESI, registration GST & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished with latest challan.
- 6.0 **The Tender Cost (Form Fee), Earnest Money Deposit (EMD), and Tender Processing Fee (TPF) must be paid by the bidder through online payment mode only, as provided on the e- tendering portal, i.e., <https://scope.ewizard.in>. In case the bidder fails to technically qualify as per eligibility criteria of the tender or is not the Lowest (L1) bidder, The EMD amount will be refunded to the bidder's account details as provided on the bidder enrollment registration page of SCOPE e-Tendering portal: <https://scope.ewizard.in>**
- 7.0 All the above certificate / documents shall be uploaded by the firm duly signed & self-attested subject to verification with original documents
- 8.0 The tender shall be submitted through only portal i.e <https://scope.ewizard.in>
- 9.0 Tenderers are advised to submit their offers strictly based on the layout (if any) , design parameters, specific requirements, terms & conditions and specifications given in the tender document and instruction to bidder.
- 10.0 Copies of similar works executed / in hand for high rise multi-storied office building during last three years along with work order & clients performance certificate. All the above certificate/documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents.
