4. Tenderer must be registered under ESI, PF, GST, Income Tax act, PAN No. and should have valid Electrical Contractor License. Copies of registration papers along with details need to be furnished Latest ESI & PF deposit with challan authority is also needed.
5. Average annual financial turn over on Electrical works should be at least 100% of the estimated cost during the immediate last 3 consecutive financial year and copy of Balance sheet with ITR for previous three years.
6. All the above certificate / documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents.
7. The tender shall be submitted through only portal i.e <https://scope.ewizard.in>.
8. Tenders are invited to submit their offers strictly based on the layout, design parameter, specific requirement, terms & conditions and Specifications given in the tender document and instruction to bidder.
