4. Tender document shall be issued only to reputed, specialized Contractors working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing the original document in this regard.

OR


Two similar completed similar works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

5. Tenderer must be registered under ESI, PF, GST, Income Tax act , PAN No. and should have valid Electrical Contractor License. Copies of registration papers along with details need to be furnished Latest ESI & PF deposit with challan authority is also needed.

All the above certificate/documents shall be submitted by the firm duly signed & self-attested subject to verification with original documents
